Recommendations from ISO/IEC JTC1/SC22 AG Meeting

Recommendation 1:    Submission of SC22 Project Status Lists and Meeting Calendars

SC22AG urges its WG conveners to supply the SC22 Secretariat, with up to date information on the status of each of the projects as assigned to them.

SC22AG urges its WG conveners to supply the SC22 Secretariat with an exact calendar of planned meetings.

This information should be submitted to the Secretariat not later than November 15, 1988 and updated as necessary thereafter.

Recommendation 2:    Progress of SC22/WG Project JTC1.22.02

SC22AG

- Understands and shares the WG5 sense of urgency that a revised Fortran standard be produced as soon as possible.
- Urges WG5 and ANSI to make every effort to secure synchronization of the international and US national versions of the proposed Fortran standard.
- Urges ANSI to make every effort to adhere to the schedule outlined in Resolution 5: Revised Fortran Standard, of N559: Final Report from SC22/WG5 - Fortran, to the SC22AG meeting; at a minimum a draft revision of the Fortran standard is requested in time for circulation for SC22 ballot prior to the WG5 meeting scheduled for July 1989.
- Urges ANSI to make every effort to provide for all of the requirements stated in Resolution 2: Revision of DP1539, of N 559 in the proposed draft Fortran standard.

Recommendation 3:    WG Conveners Attention to SC22 Published Documents

SC22AG urges each Working Group Convener to review with their WGs the implications and application of the following documents:

- Guidelines for the preparation of Programming Language Standards.
- Test Methods for Programming Language Processors.
- Language Binding Techniques.

Recommendation 4: Distribution of Working Documents

1. SC22AG directs the SC22 Secretariat to remind Working Group Conveners that they must follow the rules for distribution of Working Group documents contained in SC22 N190, in particular one copy of all such documents must be sent to:
  - the P Member Bodies of SC22.
2. Member bodies, which hold WG secretariat, are urged to ensure that their Conveners are provided with correct names and addresses of member bodies. Member bodies are further reminded that they have a responsibility to ensure that Working Group Conveners and the SC22 Secretariat are informed of changes in names and address of designated experts.

Recommendation 5: Response to JTC1/SC22/WG5

SC22AG notes resolution P1: Letter concerning International Fortran Standard, in document JTC1/SC22 N559 and expresses its concern that a situation has developed in the standardization of Fortran which led to the adoption of such a resolution. SC22AG acknowledges with gratitude the steps which have been taken previously by the US Member Body to impress upon those concerned, the importance of alignment of national and international standards, and requests the US Member Body to take whatever further steps they feel necessary to meet the concerns expressed in the WG5 resolution.

Recommendation 6: WG5 Liaison to US National Fortran Committee

SC22AG recognizes and supports the initiative of WG5 as stated in SC22 N559 Resolution P6: WG5 representation at X3J3 meeting, to appoint Mr. G. Schmitt, as its liaison representative to the next meeting of the US National Fortran Committee.

Recommendation 7: Withdrawing ECMA 127 - RPC Basic Remote Procedure Call Using OSI Remote Operations from fast-track processing

SC22AG recommends that the SC22 Secretariat transmit to JTC1 the WG11 report (SC22 N567), concerning the submission of ECMA-127 under the fast-track procedure, with the recommendation that ECMA-127 be withdrawn from the fast-track processing pending resolution of the issues identified in the WG11 report and that JTC1 Member Bodies be informed of the SC22/WG11 position.

Recommendation 8: Start dates for balloting periods

SC22AG recommends that the SC22 Secretariat make a judicious choice of start date for ballot periods bearing in mind the problems outlined in SC22 N505: Proposal to extend DP Ballot period, concerning the length of time for DP balloting period.

Recommendation 9: Synchronization of SC22/ANSI Activities

SC22AG appreciates the contribution of the US member body in SC22 N555: USA Contribution to SC22 on: Synchronization of JTC1/ANSI Activities, and recommends that SC22 Secretariat distributes this document to WG Conveners with a request for review and comment by the Working Groups, in particular noting any situations of difficulty.

Recommendation 10: Publication of Guidelines

SC22AG recommends that the SC22 Secretariat communicate with JTC1 requesting that the JTC1 Directives make specific provision for a type of Technical Report for the publication of Guidelines.

Recommendation 11: Implementation of Validation and Conformity TR's in SC22

SC22AG recommends that the SC22 Secretariat initiate an SC22 letter ballot on the proposal contained in SC22 N560: Report from SC22/WG12 - Conformity and Validation to the SC22AG meeting, to assign a new task to WG12 to provide advisory support to SC22 WG's.

Recommendation 12: One-year Interval Plenaries

SC22AG recommends that a SC22 letter ballot, proposing that SC22 plenary meetings be held at one-year intervals and requesting volunteer hosts for the 1990 and 1991 resulting plenary meetings if the proposal is approved, be sent to SC22 Member Bodies for voting.

**Abstain (UK)**

Recommendation 13: Ad Hoc Group on Character Handling Requirements

SC22AG recommends that the SC22 Chairman establish an ad hoc group, to be convened by Mr. Genuys as interim convener, for the purpose of synthesizing the issues raised in the various SC22 documents, concerning character handling requirements in programming languages, into a single

comprehensive document and proposing, for Member Bodies consideration, a possible framework for future work in the area. The AG recommends that a first draft of this document be made available to SC22 Member Bodies and WG Conveners by January 1989 and that a first meeting of the Ad Hoc Group be held in Paris, March 6-8, 1989.

**Recommendation 14: Character Sets in Programming Languages**

SC22AG recommends that the SC22 Secretariat remind Working Group Conveners of Resolution 86 in SC22 N406: Resolutions adopted at the Second Plenary Meeting of SC22, concerning handling of character sets in future standards. The SC22 Secretariat is requested to call their attention to SC22 documents N519, N540, N558, N571 and N572 for consideration in the Working Group deliberations.

**Recommendation 15: NWI, Ada/SQL**

In reference to the results of the NWI ballot, contained in document JTC1 N162, SC22AG recommends that the SC22 Secretariat advise SC21 and the JTC1 Secretariat that, in consideration of the requirement for Ada expertise to develop the Ada/SQL Interface, as defined in the NWI proposal, it is essential that the work be done in SC22/WG9 - Ada, with the assistance of Database experts from SC21/WG3.

**Recommendation 16: Posix**

In consideration of the letter ballot, contained in SC22 N545 for the division of project JTC1.22.21, SC22AG recommends that the WG15 Convener be asked to prepare an informal document on the subject of the total POSIX environment, showing the relationship of the proposed subdivision to the scope of the approved project. This document should be distributed to SC22 Member Bodies before the ballot closing date of January 13, 1989.

In the event that there is Member Body support for the proposed security sub-project, SC22AG advises that WG15 may use its discretion in the appropriate internal organization of that work, if necessary by forming a Rapporteur Group.

**Recommendation 17: Synchronization of C Standards (WG14)**

SC22AG requests the Secretariat to communicate its concern to WG14 and the US Member Body to ensure that the utmost is done to ensure synchronization of activities and the production of a common Standard for C, urging that every effort be made to accommodate WG14 comments.

Recommendation 18: NWI Consultative Ballot

The SC22AG recommends to the Secretariat that any comments accompanying an SC22 consultative ballot on NWIs be communicated, to the Member Body or Working Group proposing the item, for consideration in the further processing of the NWI. Further, that the SC22 Secretariat modify the form of the NWI consultative ballot to capture Member Body's intentions with regard to their willingness to participate in the proposed work.

Recommendation 19: Potential NWIs for SC22

SC22AG recommends that the SC22 Secretariat issue a consultative letter ballot to determine support for NWI, for:

- MUMPS
- SmallTalk
- FORTH

This letter ballot should offer National Bodies a choice with regard to procedures; "Fast Track"/normal Working Group, as well as an indication of National Body's active participation in standardization activities which may arise from this ballot.

Recommendation 20: Vienna Development Method (VDM)

SC22AG recommends to the SC22 Secretariat that the NWI proposed on VDM Specification Language, contained in JTC1 N245, be revised, taking into account the comments received from Member Bodies and resubmitted to JTC1 for approval. It is further recommended that the Secretariat, in resubmitting the NWI to JTC1, indicate that:

1. It is intended to do the bulk of the work by mail.
2. Is being used successfully in the development of the Programming Language standards.
3. The NWI has been restructured taking into account the JTC1 Recommendation on the use of Formal Description Techniques (FDT) as contained in JTC1 N152 (SC22 N483).
4. Based on points 1-3 above, it was the view of Member Bodies present at the SC22AG meeting that re-balloting would result in acceptance of the NWI.

Recommendation 21: C + +

The SC22AG recommends that the Secretariat ask the SC22 WG14 Convener to solicit the views of its experts on the desirability of initiating standardization activities on the Language C + +, and to transmit these views to the Secretariat by April 1989. The SC22AG further directs the SC22 Secretariat to inform Members Bodies of this initiative and asks for their views on this subject.

Recommendation 22: Joint Meeting - SC22/SC2/SC21/WG's

SC22AG recommends that the SC22 Chairman inform SC18 (Mr. Smura) of the steps taken at the SC22AG meeting, and decline SC22 participation in a joint meeting of SC2/SC18/SC22 as proposed in SC22 N532: Proposed meeting of SC2, SC22 and SC18 to discuss the multi-byte character set issue. It is further recommended that the SC22 Chairman organize a joint meeting of SC2 and SC22 (as proposed in SC22 N509) and of SC21/WG3 - Database, to review the overall situation concerning character handling in Programming Languages. This meeting should be scheduled for April-May 1989.

Recommendation 23: Liaison with SC's 21, 2 and 1

SC22AG directs the SC22 Secretariat to solicit Members Bodies for nominees to serve as SC22 liaison to SC21, SC2 and SC1, respectively.

Recommendation 24: IFIP TC-2 Liaison

SC22AG requests the Chairman to attempt, again, to establish liaison with IFIP TC-2, Programming Languages.

Unanimous

Recommendation 25: Resolution of comments on SC22 N478

SC22 thanks Mr. Meek for the care taken in considering and responding to the comments on N478: Proposed DTR on Guidelines for the Preparation of Programming Language Standard. The AG urges all concerned that they keep in mind the objective of achieving the broadest possible support in order to secure early publication of the Technical Report.

SC22AG draws attention to N533: Project Editor's proposed responses to comments received on N478, as an aid to completion of the project and requests the project editor to use his best efforts to submit the document in its final form by 30 April 1989.

Recommendation 26: Appreciation

SC22AG thanks Mr. G. Schmitt for his excellent presentation on character set handling in FORTRAN.
